

A Form W-9 is a document required by the Department of the Treasury Internal Revenue Service. The purpose of the form is to request the taxpayer identification number (TIN) of a U.S. person or entity. This form helps us to accurately report payments to the Internal Revenue Service (IRS) and also ensures compliance with tax regulations.

The Form W-9 includes information such as the taxpayer's name, business name (if applicable), address, taxpayer identification number (SSN or EIN), and certification that the taxpayer is not subject to backup withholding due to underreporting of interest or dividends.

It's important for taxpayers to provide accurate information on Form W-9 to avoid potential penalties and ensure correct tax reporting.

On the following IRS Form W9, please ensure to provide the following:

- **Field 1** Full name on the account
- **Field 2** The full business name, if applicable
- **Field 3a** Check the appropriate box, if applicable
- **Field 3b** Check the appropriate box, if applicable
- **Field 4** Check the appropriate box, if applicable
- **Field 5 & 6** Full mailing address
- **Field 7** The name of the stock and your account number with Continental Stock Transfer
- **Part I** Provide a SSN or EIN number
- **Part II** Sign and Date the form in the "Sign Here"

Part I Taxpayer Identification Number (TIN)

Enter your TIN in the appropriate box. The TIN provided must match the name given on line 1 to avoid backup withholding. For individuals, this is generally your social security number (SSN). However, for a resident alien, sole proprietor, or disregarded entity, see the instructions for Part I, later. For other entities, it is your employer identification number (EIN). If you do not have a number, see *How to get a TIN*, later.

Note: If the account is in more than one name, see the instructions for line 1. See also *What Name and Number To Give the Requester* for guidelines on whose number to enter.

Part II Certification

Under penalties of perjury, I certify that:

1. The number shown on this form is my correct taxpayer identification number (or I am waiting for a number to be issued to me); and
2. I am not subject to backup withholding because (a) I am exempt from backup withholding, or (b) I have not been notified by the Internal Revenue Service (IRS) that I am subject to backup withholding as a result of a failure to report all interest or dividends, or (c) the IRS has notified me that I am no longer subject to backup withholding; and
3. I am a U.S. citizen or other U.S. person (defined below); and
4. The FATCA code(s) entered on this form (if any) indicating that I am exempt from FATCA reporting is correct.

Certification instructions. You must cross out item 2 above if you have been notified by the IRS that you are currently subject to backup withholding because you have failed to report all interest and dividends on your tax return. For real estate transactions, item 2 does not apply. For mortgage interest paid, acquisition or abandonment of secured property, cancellation of debt, contributions to an individual retirement arrangement (IRA), and, generally, payments other than interest and dividends, you are not required to sign the certification, but you must provide your correct TIN.
