

### **Direct Deposit Form**

Direct Deposit is the electronic bank-to-bank payment system referred to as the automated clearing house (ACH). The ACH process eliminates the need for paper checks and allows for quick, easy, and secure delivery of your funds.

While Direct Deposit is very beneficial, it is only offered by participating companies. A list of participating companies is listed on the reverse side of this page. Furthermore, Direct Deposit is only applicable to dividend payments and excludes any other type of payment. Lastly, Direct Deposit can only be made to a bank located in the United States.

For accounts registered as a corporation, a copy of the corporate resolution is required showing the names of the corporate officers authorized to act on the behalf of the corporation. Also if an account is registered as a Trust, a copy of the trust agreement's first and last page showing the names of the trustees authorized to act on the behalf of the Trust is required. In either instance, the receiving bank account ownership registration must match the Continental Stock Transfer account registration.

For security and convenience, upon completion of a Direct Deposit payment, a confirmation statement is mailed to the address on record.

In order to establish Direct Deposit for your account, please complete the form. Alternatively, the Direct Deposit can be completed through our secure website access. If you require website access, please contact us at the phone number below.

Here are some reminders to ensure the complete and accurate submission of the Direct Deposit Form:

- Provide the full registration of the account with Continental Stock.
- If a checking account is used to receive the dividends, please include a voided check.
- For payment deposited into a savings or credit union account, please include a voided deposit slip or a bank letter with the owner's full name on the bank account.
- All owners or authorized individuals on the account must sign the Direct Deposit Form.
