

# Direct Deposit Form

Direct Deposit is an electronic payment method that transfers funds directly between banks through the Automated Clearing House (ACH) network. This system removes the need for paper checks, providing a faster, more convenient, and secure way to receive payments.

Although Direct Deposit offers many advantages, it is only available through participating companies, which are listed on the reverse side of this page. It applies exclusively to dividend payments and cannot be used for any other types of transactions. Additionally, deposits can only be made to bank accounts located within the United States.

For accounts registered under a corporation, a copy of the corporate resolution must be submitted, identifying the officers authorized to act on behalf of the company. For trust accounts, copies of the first and last pages of the trust agreement are required to verify the trustees authorized to act on behalf of the trust. In all cases, the ownership details of the receiving bank account must match the registration on the Continental Stock Transfer account.

For added security and recordkeeping, a confirmation statement will be mailed to the address on file each time a Direct Deposit payment is completed.

To set up Direct Deposit, please fill out the required form. You may also complete the process through the secure online portal; if you need access, contact the number provided below.

To ensure your form is processed accurately, please follow these guidelines:

- Include the full account shareholder name as it appears with Continental Stock.
- If using a checking account, attach a voided check.
- For savings or credit union accounts, include either a voided deposit slip or a bank letter showing the account holder's full name.
- All account owners or authorized individuals must sign the form.

# Direct Deposit Form Instructions

1. Provide the name of the stock held with Continental Stock Transfer.
2. Enter the full registration details of your Continental Stock Transfer account.
3. Include your Continental Stock Transfer account number.
4. Provide the Social Security Number (SSN) associated with the account.
5. List the full name of the financial institution where the funds will be deposited.
6. Provide the address of that financial institution.
7. Enter the nine-digit routing number for the bank (this can be found on a check or obtained from the institution).
8. If depositing into a checking account, attach a voided check. For savings or credit union accounts, include a voided deposit slip or a bank letter showing the account holder's full name.
9. Provide the complete account number for the bank account receiving the deposit. Ensure accuracy, as the information will be verified.
10. All registered owners must sign the Direct Deposit Authorization form.
  - **For corporate accounts:** include a corporate resolution listing authorized officers, and ensure those officers sign the form.
  - **For trust accounts:** include the first and last pages of the trust agreement identifying authorized trustees, and ensure the trustees sign the form.
  - In all cases, the bank account ownership must match the Continental Stock Transfer account registration.
11. Provide a daytime phone number for the individual(s) completing the form in case further contact is needed.
12. Indicate the date the Direct Deposit Authorization form is completed.
